3.The learned Government Advocate (Crl.Side) appearing for the respondents would submit that already they had received the representation of the petitioner and conducted enquiry in CSR No.33 of 2025, dated 10.02.2025. The petitioner has sent his representation only through post, thereafter, neither he appeared for enquiry nor co-operated with the respondents for enquiry. However, if the petitioner appears before the 3rd respondent and furnish the relevant documents, the respondent will conduct enquiry and take appropriate action by considering the representation of the petitioner.
