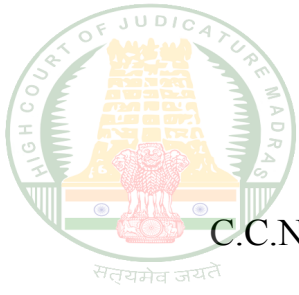

This Criminal Original Petition has been filed by the petitioner to direct the learned Judicial Magistrate, Sathankulam to expedite the trial in C.C.No.14 of 2024 and to complete the trial within the time stipulated by this Court.

2. According to the petitioner, he is the accused in this case and the date of F.I.R is 24.05.2023. Now, the case is pending in C.C.No.14 of 2024 and the case is posted for examination of witnesses, but no witnesses have been produced for examination of witness. The case is pending for more than two years, thereby he filed this petition.

3. The Government Advocate (Criminal) appearing for the first respondent would submit that now the case is posted for examination of witnesses and they have to produce the witnesses. They will cooperate for the speedy disposal by producing witnesses as directed by the Trial Court.
