ORDER

This petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Crime No.318 of 2024 dated 28.09.2024 on the file of the first respondent police, for the offences under Sections 281, 125(A), 281, 106(2), 238 of BNS Act and quash the same.

2. When the matter was taken up for hearing, the learned counsel on both sides represented that the matter has also been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and all the accused are present and this Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise and he has no objection to quash the FIR. A compromise memo, dated 27.02.2025 signed by the parties and their respective counsel, is also filed before this Court.
