ORDER

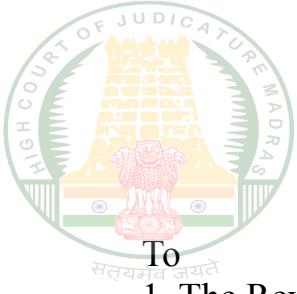
When the matter came up for hearing today, the learned counsel for the petitioner sought permission of this Court to withdraw the petition and he has also made an endorsement to that effect.
