4. The petitioner has made an application for survey on 12.12.2023 and again on 05.04.2024, both of which have not been disposed of. In view of the above, the petitioner seeks the limited relief of issuance of a writ of mandamus to direct the respondents to pass

orders on the petitioner's online application dated 12.12.2023 and 05.04.2024.
