PRAYER: Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, directing the respondent to pay the petitioner the amount towards the encashment of 239 days of earned leaves, surrendered by him in the years from 2004 to 2020 before her retirement, either based on his monthly wages of the respective months of surrender of those earned leaves, together with 18% interest p.a. from the respective due dates or based on the monthly wages payable on the month of this retirement, together with 18% interest from the date of her retirement, with a time frame as may be fixed by this Court.

ORDER

The present Writ Petition has been filed by a retired Special Grade Tradesman of the respondent Transport Corporation, seeking disbursement of the earned leave and surrender leave salary along with interest.

2. Though the petitioner has retired on 30.06.2019, the earned leave and surrender leave salary have not been disbursed to the writ petitioner, despite giving representation to the respondent on 18.07.2024, for disbursing the said benefits. Since the representation has not been considered, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondent.

4. Considering the above said facts, the respondent herein is directed to release the eligible earned leave and surrender leave salary to the writ petitioner

along with interest at the rate of 6% p.a., from the due date till the date of
disbursement, within a period of twelve weeks from the date of receipt of a copy
of this order.

5. With the above said observations, this Writ Petition stands disposed of.
