4.Considering the nature of order proposed to be passed in this petition, notice to the respondents 2 and 3 is dispensed with.

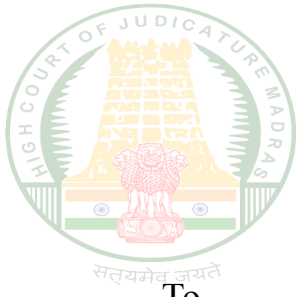
