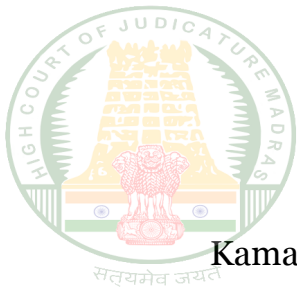

2. Mr.B.Jameel Arasu, counsel for petitioner, states, he will advise his client accordingly.

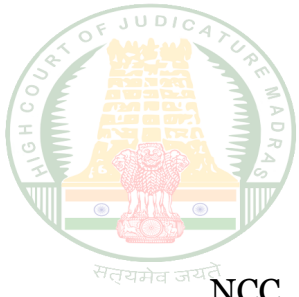
