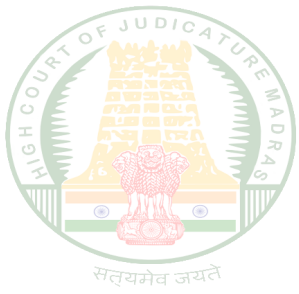

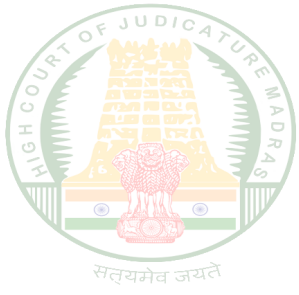
ORDER

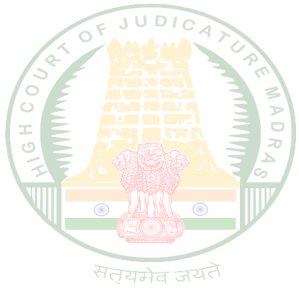
