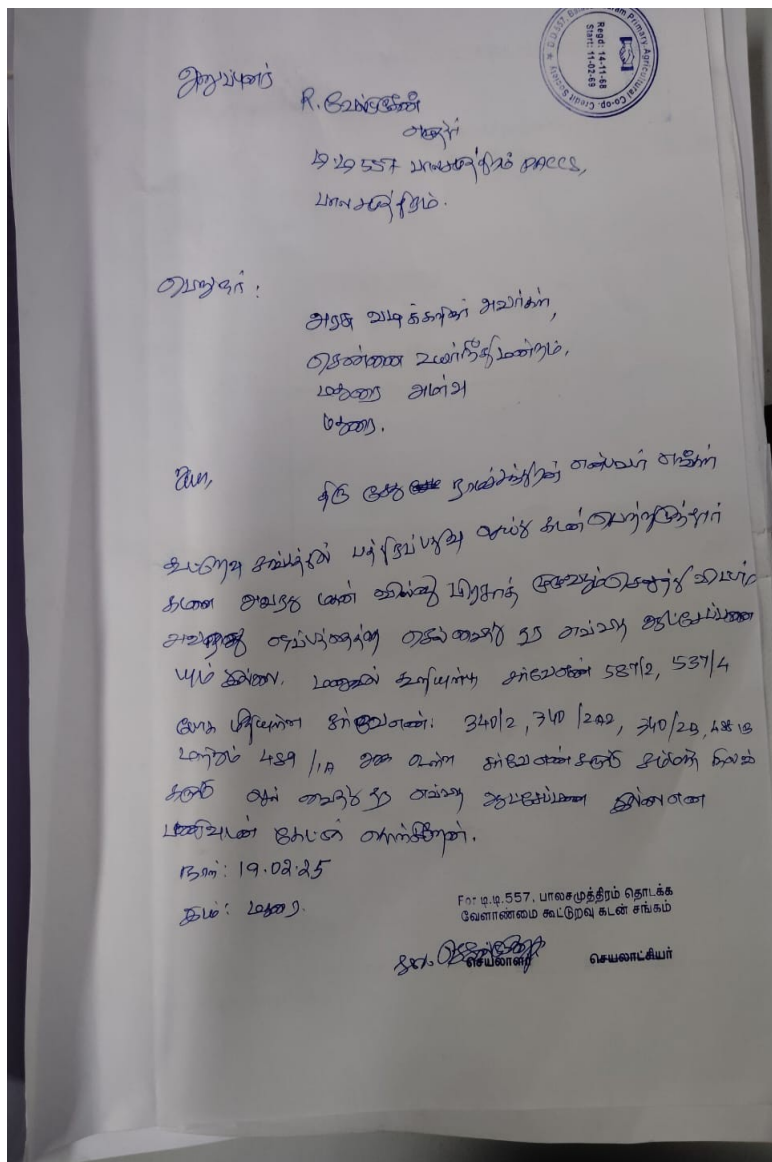
2. The petitioner seeks for mandamus directing the first respondent to execute a discharge receipt and the second respondent to register the same.
