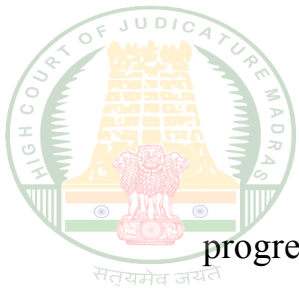

3. At this juncture, the learned counsel for the petitioner represents that the charge sheet was returned for some defects.

4. This Court heard both sides and perused the records.

5. This Court already recorded in the earlier order, dated 28.08.2024, in Crl.OP(MD)No.2388 of 2023 that the charge sheet was filed on 18.04.2024, before the Judicial Magistrate, Tirunelveli in E.filing No.CC-LTN-2022 000 1861, C2024 00152. But, thereafter, there is no
