Prayer: Writ Petition filed under Article 226 of the Constitution of India to issue Writ of Certiorarified Mandamus to call for the records in pursuant to the impugned notice passed by 4th respondent under Section 7 of the Tamil Nadu Land Encroachments Act, 1905 dated 06.11.2024 and quash the same as illegal and consequently directing the respondents to provide alternative remedy to the petitioner as per G.O.Ms No.318 dated 30.08.2019 and subsequent period extend in Government Orders in G.O.Ms.No.480 dated 11.09.2020, G.O.Ms.No. 267 dated 17.09.2021 (rectified G.O.Ms.No.622, dated 01.10.2021) and G.O.Ms.No. 462 dated 23.09.2022 on the basis of the petitioner's representation dated 17.12.2024.

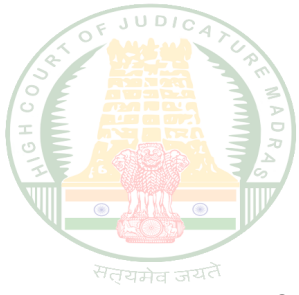

2.In this writ petition, the petitioner questions the notice issued under Section 7 of the Tamil Nadu Land Encroachment Act, 1905. It is well settled that notice is not amenable to challenge unless want of jurisdiction is shown. The impugned notice has been issued by the Revenue Inspector. Section 7 of the Act recognises him as one of the authorities competent to issue notice. It is for the petitioner to submit proper explanation. If any adverse order is passed, it is open to him to move this Court again.
