3. Accordingly, this Writ Miscellaneous Petition is allowed.

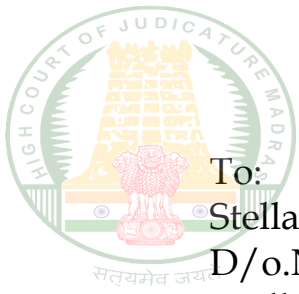
