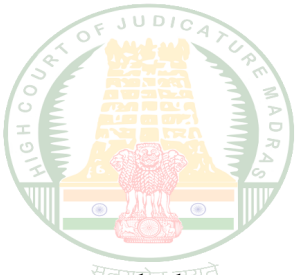
Prayer :-

4. The above compliance of the respondents is hereby recorded”.

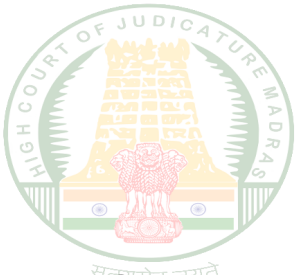
