2.While allowing the said writ petition, this Court directed the respondents therein to disburse all the monetary benefits including the arrears of salary from 17.06.2009 onwards till June 2022 within a period of twelve weeks from the date of receipt of copy of that order.

3.The learned counsel for the petitioner submits that since the order of this Court has not complied with within the stipulated time granted by this Court, the petitioner was constrained to file this contempt petition.

4.There is discrepancy with regard to the date of communication of the order of this Court to the respondents. The learned counsel on either side are not coming with correct particulars about the date of service of the order of this Court. However, it is now reported that the respondents implemented the order of this Court and disbursed all the monetary benefits to the petitioner for which she is legitimately entitled vide G.O.(D)No.69, Higher Education (E2) Department dated 01.04.2025.

5.It appears that admittedly, there is some delay in implementing the order of this Court. Considering the reasons stated in the counter affidavit filed by the respondents, this Court intends to take lenient view towards delay occurred in implementing the order of this Court.

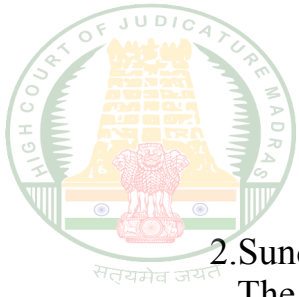
