3. Heard the learned counsels on either side.

Without going into the merits of the case, this Court directs the 2nd respondent to consider the representation of the petitioner, dated 08.02.2023 and pass orders after affording an opportunity of personal hearing to the petitioner. The said exercise shall be completed within a period of one (1) month from the date of receipt of copy of this order.
