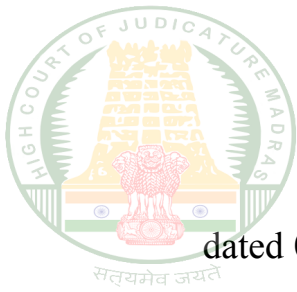

ORDER

This petition has been filed by the petitioner to call for the records pertaining to the First Information Report in Crime No.26 of 2025 dated 16.01.2025 on the file of the first respondent police, for the offences under Sections 296(b), 118(1) and 351(3) of BNS and quash the same.

2. When the matter was taken up for hearing, the learned counsel on both sides represented that the matter has also been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and the accused are present and this Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise as they belong to same village and he has no objection to quash the FIR. A compromise memo,
