ORDER

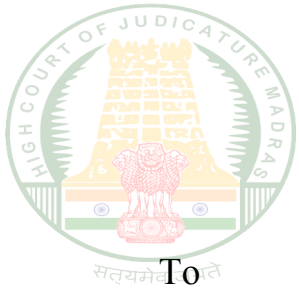
The learned Counsels appearing on either side submit that the order of this Court has been complied with.
