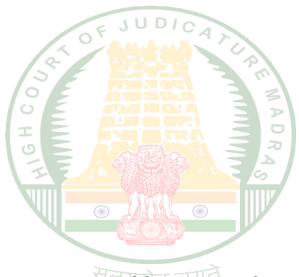

ORDER

"The petitioner shall report before the learned Judicial Magistrate, Rajapalayam, Virudhunagar, on all working days at 10.00 a.m., until further orders."
