## **ORDER**

This petition has been filed by the petitioner to call for the records pertaining to the First Information Report in Crime No.55 of 2025 dated 22.01.2025 on the file of the first respondent police, for the offences under Sections 296(b), 126(2), 351(3) of BNS 2023 and Section 4 of TN Prohibition of Harassment of Women Act, 2002 and Under sections 67 of IT Act, 2000 and quash the same.

2. When the matter was taken up for hearing, the learned counsel on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court. The petitioner has also assured that he has not taken any video as alleged by the prosecution.

3. The defacto-complainant and the accused are present and this Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise and she has no objection to quash the FIR. A compromise memo, dated 11.03.2025 signed by the parties and their respective counsel, is also filed before this Court.
