### ORDER

5. Considering the reasons, this Court is inclined to modify the conditions imposed vide order, dated 18.12.2023. The petitioners are directed to appear before the concerned Court on the first working day of every alternative English calender month at 10.30 am, until further orders, starting from the month of March.
