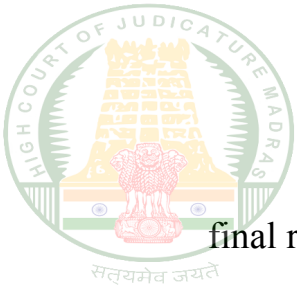

ORDER

This Criminal Original Petition has been filed seeking to quash the FIR in Crime No. 23 of 2024 on the file of the first respondent.

2.When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondents submitted that in the present case after completion of investigation final report was filed before the Judicial Magistrate No.V, Madurai and the same was taken on file as CC No.591 of 2024. Hence, nothing survives for further adjudication.
