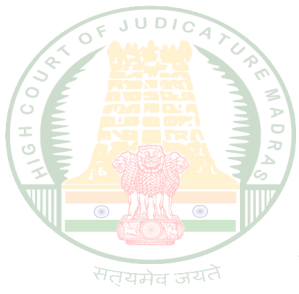

This petition has been filed by the petitioner/Accused No.3 to call for the records pertaining to the First Information Report in Crime No. 2609 of 2016 dated 07.12.2016 on the file of the first respondent police, for the offences under Sections 147, 148, 448, 324 and 506(2) of IPC and quash the same.

2. When the matter was taken up for hearing, the learned counsels on both sides represented that the matter has been amicably settled between the parties and to that effect, they have entered into a compromise and the same was filed before this Court.

3. The defacto-complainant and the petitioner are present and this Court enquired about the terms of compromise. The defacto-complainant represented that they entered into a compromise and he has no objection to quash the FIR. A compromise memo, dated 18.02.2025 signed by the parties and their respective counsel, is also filed before this Court.

4. This Court has perused the terms of the compromise memo.

into a compromise, it is appropriate to allow this petition.

The compromise memo dated 18.02.2025 filed by the parties shall form part of this order.
