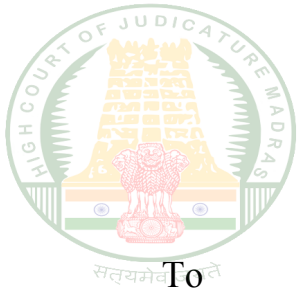

2.When these petitions are taken up for hearing the learned Government Advocate(Crl.side) appearing for the respondent police submits that after completing the investigation final report in Crime No.533 of 2023 has already been filed and it is taken on file in CC.No.121 of 2024 on the file of the learned Judicial Magistrate, Valliyoor and the final report in Crime No.534 of 2023 is yet to be taken on file.
