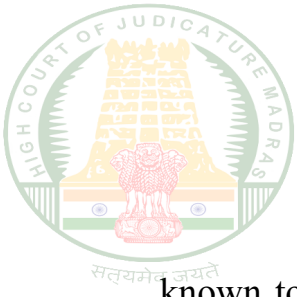

ORDER

This Criminal Original Petition has been filed by the petitioners to call for the records pertaining to the First Information Report in Crime No.751 of 2024, dated 30.12.2024 for the offences under Sections 296(b), 118(2) and 351(3) of the Bharatiya Nyaya Sanhita, 2023 and Section 4 of the Tamil Nadu Prohibition of Harassment of Women Act, 2002 on the file of the first respondent police and quash the same.

2. When the matter was taken up for hearing, the learned Counsels on both sides represented that the matter has been amicably settled between the parties and they have entered into a compromise and the same was filed before this Court.
