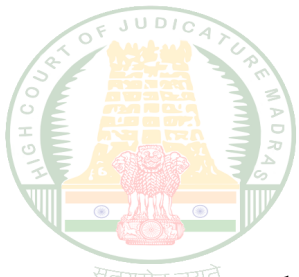
PRAYER :-
