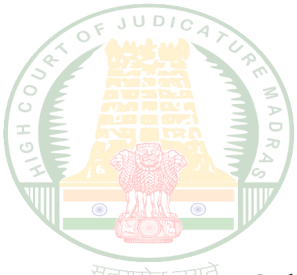

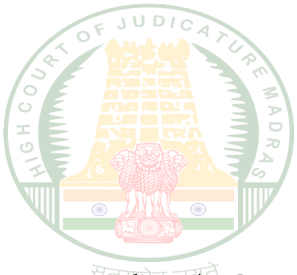
“This petition is listed under the caption 'for Amendment'.
