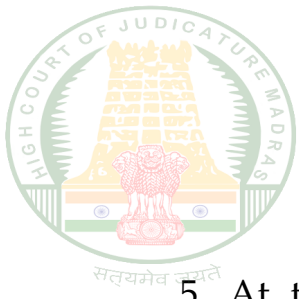
ORDER : The Court made the following order :-

This Criminal Original Petition has been filed by the petitioner on 27.02.2025 under Section 483 of Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023, praying to grant bail.

2. The petitioner / Sole Accused was arrested and remanded to judicial custody on 12.01.2025 for the offences punishable under Sections 4(1)(C) and 4(1)(A) of Tamil Nadu Prohibition (Amendment) Act in Crime No.10 of 2025 on the file of the respondent-Police.

3. Today, when the matter is taken up for hearing, Mr.K.Prakash, learned counsel appearing for the petitioner submits that the petitioner had already been released on bail by the learned Judicial Magistrate, Bodinayakkanur, Theni District in CrI.M.P/0000438/2025 vide order dated 26.02.2025 during the Prison Adalath. He has also produced a copy to that effect.

4. Mr.K.Sanjai Gandhi, learned Government Advocate (Criminal Side) confirmed the said fact.
