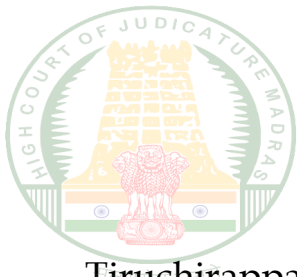

ORDER

2. This Court, while suspending the sentence on 03.01.2025, directed the petitioner to appear before the learned II Additional District and Sessions Judge,

3. The learned counsel appearing for the petitioner submits that the petitioner is regularly complying with the condition from 27.01.2025 onwards. He further submits that the petitioner is aged about 67 years and he is suffering with old age ailments. Further, he has to travel from her home to trial Court for nearly 120 kms. daily. Therefore, he seeks for relaxation of the said condition.

4. The learned Government Advocate (Crl. Side) has also confirmed that the petitioner is regularly complying with the condition from 27.01.2025 onwards.

5. Considering the fact that the petitioner is complying with the condition from 27.01.2025 onwards, this Court is inclined to modify the condition imposed in Crl.M.P.(MD)No.13991 of 2024.

6. Accordingly, this Criminal Miscellaneous Petition is allowed and the condition is modified to the effect that the petitioner shall appear before the trial Court once in a week, i.e. on every Monday at 10.30 a.m., till the disposal of the appeal.
