2.When the matter is taken up for hearing, the learned Government Advocate (Crl.Side) appearing for the respondent police would submit that the petitioner has sought for police protection only to conduct survey and the survey has already been conducted by the respondents. Therefore, prayer of the petitioner has become infructuous.
