ORDER

This Criminal Original Petition has been filed to direct the second respondent not to harass the petitioner under the guise of enquiry by considering the petitioner's representation, dated 20.02.2025.

2. According to the petitioner, the petitioner was falsely implicated in two cases. Therefore, now the second respondent in order to put up a case against him, searching the petitioner and harassed the petitioner by searching the petitioner in his house. Apart from that they have not made any harassment to anybody. They only for the purpose of search went to the petitioner's house and enquired the family members about his presence.

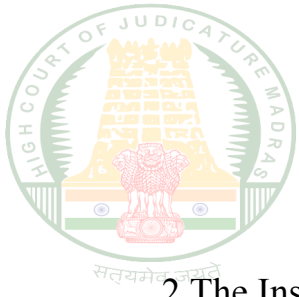
