Heard the learned counsel on either side and perused the materials available on record.

2.Considering the limited scope of the relief sought for by the petitioner, with the consent of learned counsel on either sides, this writ petition is taken up for final disposal.

3.The petitioner seeks correction to the extent of the revenue records by incorporating the correct extent of 26.5 cents instead of 22 cents. The petitioner has made a request to the 3rd respondent, which was rejected.

4.It is the admitted case of the petitioner that the 3rd respondent has already inspected the petitioner's property and
