2. In view of the above fact, nothing survives in this writ petition.

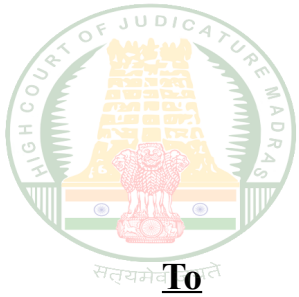
3. Accordingly, this Writ Petition stands dismissed. No costs.
