Hence, he seeks permission of this Court to deposit a sum of Rs.8,00,000/-. Therefore, he prays for the modification and extension of time to comply with the condition No.7(iii) of the order passed in the said petition.

Considering the facts and circumstances of the case and also considering the reasons stated in the affidavit filed in support of this petition and also considering the request made by the petitioner, this Court is inclined to modify the condition stated in Paragraph No.7(iii) of the order in the said petition and the petitioner shall deposit a sum of Rs.8,00,000/- within a week from the date on which the order passed and shall deposit the remaining amount with 40 days from the date on which the order passed i.e., 15.04.2025 to the credit of the Crime No.40 of 2024, on the file of the
