PETITION FOR ANTICIPATORY BAIL Under Sec.482 of BNSS

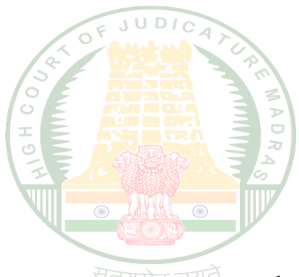
PRAYER :-

Today, when the matter is taken up for hearing, Mr.R.Meenakshi Sundaram, learned Additional Public Prosecutor appearing for the respondent-Police, on instructions, submits that the issue is settled between the defacto complainant and the petitioner. To that effect, defacto complainant has given a statement before the respondent-Police. In view of the statement, the respondent-Police closed the complaint given by the defacto complainant. Therefore no case or no First Information Report is registered against the petitioner. Hence, the petitioner has no reasonable apprehension of arrest. 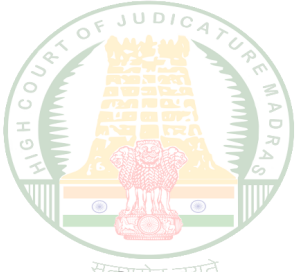
3. In view of the submissions, the petitioner has no apprehension of arrest. Hence, this Criminal Original Petition is dismissed.
