ORDER

This Criminal Original Petition has been filed to direct the third respondent not to harass the petitioner in the guise of enquiry in respect of complaint made towards the land dispute comprised in Survey No.363/3 of Thiruviruthanpuli Part II Village, Cheranmahadevi Taluk, Tirunelveli District.

2. The learned Government Advocate (Crl. Side) appearing for the respondents would submit that already based on the complaint given by the de facto complainant, they conducted enquiry and closed the same.
