PETITION FOR ANTICIPATORY BAIL Under Sec.482 of BNSS

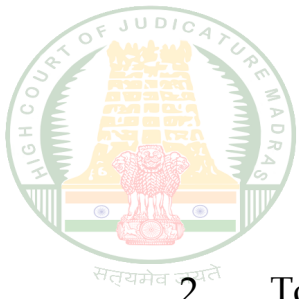
PRAYER :-
