2.It is the grievance of the petitioner that his representation dated 24.02.2025, seeking removal of the encroachment made by the 4th respondent in the common pathway in T.S.No.107 situated at Ward No.17, Paramakudi Town, Ramanathapuram District, is kept pending till date without any progress. Therefore, he has filed this Writ Petition, seeking for a direction to the 2nd respondent to remove the alleged encroachment.

3.Mrs.D.Farjana Ghoushia, learned Special Government Pleader, who takes notice on behalf of the respondents 1 and 2, submits that the 3rd respondent is the competent authority to consider the representation of the petitioner.

4. Notice to the respondents 3 and 4 is hereby dispensed with, since no adverse order is going to be passed as against them.

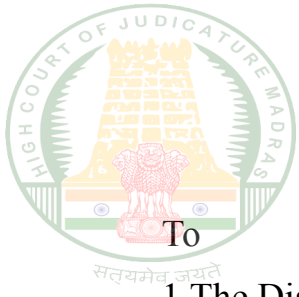
