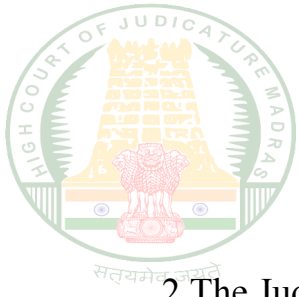
6. With the above said observations and directions, this Criminal Original Petition stands disposed of.
