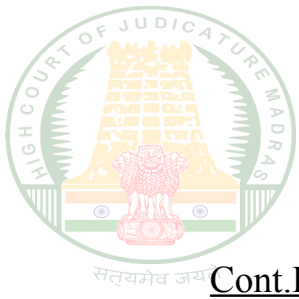

COMMON ORDER
