2.According to the petitioner, he is the defacto complainant. Based on his complaint, a case in Cr.No.300 of 2024 has been registered on the file of the 3rd respondent. Thereafter, the 3rd respondent without conducting investigation in a proper manner, closed the complaint as 'mistake of fact' and copy of closure report has not been served to the petitioner.

3.Today, when the matter is taken up for hearing, the learned Additional Public Prosecutor appearing for the respondent police furnished the copy of closure report along with the documents to the
