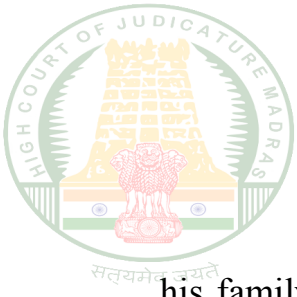

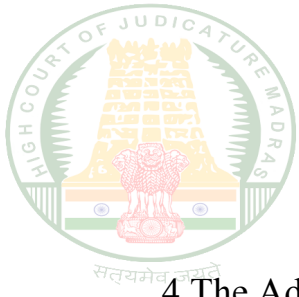
4. Accordingly, this Criminal Original Petition stands closed.
