**PRAYER:** Writ Petition filed under Article 226 of the Constitution of India for issuance of Writ of Mandamus, directing the respondent to pay the petitioner amount towards the encashment of 125 days of earned leaves, surrendered by him in the years from 2011 to 2019 before his retirement, either based on his monthly wages for the respective months of surrender of those earned leaves, together with 18% interest p.a from the respective due dates or based on the monthly wages payable on the month of his retirement, together with 18% interest from the date of his retirement, within a time frame as may be fixed by this Court.

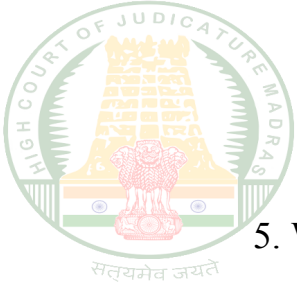
## **ORDER**

**WEB COPY** The present Writ Petition has been filed by a retired Junior Security Guard of the respondent Transport Corporation, seeking disbursement of the earned leave and surrender leave salary along with interest.

2. Though the petitioner has retired on 30.11.2019, the earned leave and surrender leave salary have not been disbursed to the writ petitioner, despite giving representation to the respondent on 28.01.2025, for disbursing the said benefits. Since the representation has not been considered, the present writ petition has been filed.

3. Heard the learned counsel appearing for the petitioner and the learned Standing Counsel appearing for the respondent.

4. Considering the above said facts, the respondent herein is directed to release the eligible earned leave and surrender leave salary upon the writ petitioner along with interest at the rate of 6% p.a., from the due date till the date of disbursement, within a period of twelve weeks from the date of receipt of a copy of this order.
