ORDER

The petitioner seeks for issuance of a writ of mandamus to direct the third respondent, viz., The Thasildar, Papanasam, to cancel the patta issued in patta No. 92 and to consequently issue a fresh patta in the name of the petitioner.

3. The petitioner has given a representation in this regard through on-line on 09.12.2024 and he seeks disposal of the said representation dated 09.12.2024.

Today (i.e.,24.03.2025), when the matter is taken up for final hearing, the learned Additional Government Pleader, Mrs.K.Malathi, would submit that the subject matter revolves around UDR correction and hence, the petitioner would have to make application before the District Revenue Officer, Kumbakonam. The District Revenue Officer, Kumbakonam is not arrayed as a party respondent in the writ petition.
