ORDER

The petitioner has sought for issuance of Writ of Mandamus to direct the third respondent to issue patta in his favour, based on his representation dated 28.01.2025.

2.Mr.B.Saravanan, learned Additional Government Pleader would however invite my attention to the representation of the petitioner and contend that the mistake which according to the petitioner that has crept in, was during the time of UDR, when the subject survey number was classified as “Kalam poramboke” and would therefore, submit that the petitioner has to approach the District Revenue Officer, Virudhunagar and the District Revenue Officer has not been made as a party in the present Writ Petition.
