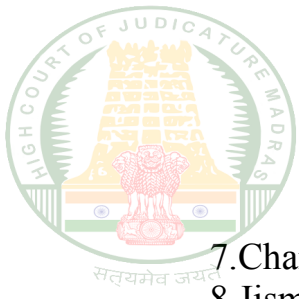

2.The petitioner seeks for issuance of a Writ of Mandamus to direct the fourth respondent to restore the petitioner's patta in Patta No. 3351, which has been fraudulently, according to the petitioner, transferred in the name of the respondents 6 to 33. The petitioner has

already given a representation in this regard on 31.01.2025 to the revenue officials.

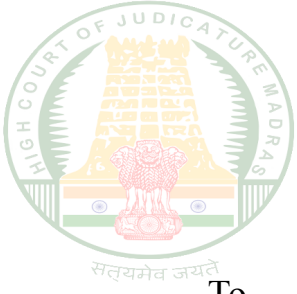
