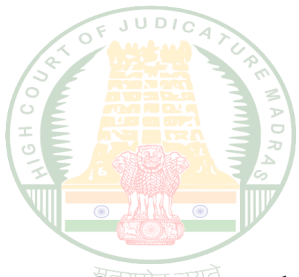

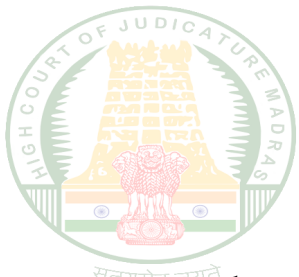

“This Criminal Miscellaneous Petition has been filed seeking orders to modify the condition directing the petitioner to surrender and execute the sureties before the Principal District and Sessions Court, Nagercoil by order, dated 08.08.2024 in Crl.M.P(MD) No.7949 of 2024 in Crl.M.P(MD)No.12641 of 2023 in Crl.RC(MD)No.388 of 2020 on the file of this Court.

2.The learned counsel for the petitioner would submit that the petitioner has filed a petition in Crl.MP(MD)No.7949 of 2024, seeking extension of time to comply with the modified conditions imposed in Crl.MP(MD)No.12639 of 2023, dated 12.10.2023 and the prayer claimed in the petition is extracted hereunder :

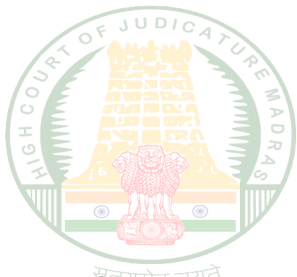
