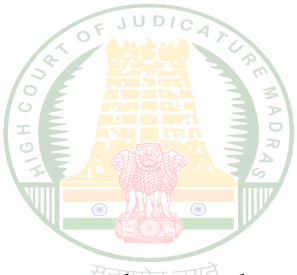
For Bail in Crime No. 28 of 2025 on the file of the respondent Police.
