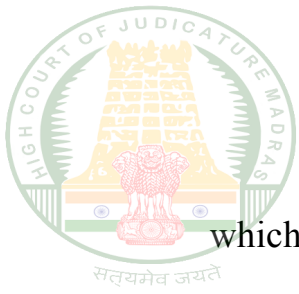

ORDER

This Writ Petition has been filed seeking a direction to the third respondent to take further action upon the petitioner's complaint dated 13.02.2025.

2.According to the petitioner, in the name of job racketeering, one Kumar and his family cheated the petitioner and he is the one of the victims and he lost money for arranging job to his daughter. Therefore, he lodged a complaint before the third respondent and the same has not been considered. Hence this petition.

3.The learned Additional Public Prosecutor appearing for the respondent police would submit that the respondent police have received the petitioner's complaint dated 13.02.2025 and apart from this complaint, two other complaints were lodged by some other victims,

which are under consideration and the same will be considered and disposed of within a period of fifteen days.

5.With the above direction, this Writ Petition is disposed of.
