petitioner shall appear and sign before the learned Judicial Magistrate, Pattukkottai, daily at 10.30 am until further orders, the petitioner is not able to comply with the aforesaid condition and seeks modification of the order passed by this Court in Crl.M.P.No.1934 of 2025 in Crl.O.P(MD). No.20500 of 2024, dated 19.02.2025. Crl.M.P.No.13781of 2024 in Crl.O.P(MD). No.20838 of 2024, dated 16.12.2024.

3. Heard Mr.S.S.Manoj, learned Government Advocate (Crl. Side) appearing for the respondent-Police.

4. Being satisfied with the reasons stated in the petition, this Court is inclined to modify the condition imposed on the petitioner in the said Petition.

5. Accordingly, the condition already imposed by this Court in Crl.M.P.No.13781of 2024 in Crl.O.P(MD). No.20838 of 2024, dated 16.12.2024 is modified to the effect that the petitioner shall stay at Madurai and report before the Judicial Magistrate No.I, Madurai on all working days at 5.30 pm until further orders. The other conditions shall hold good.

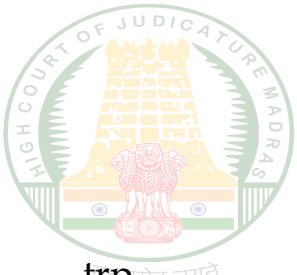
5. To that extent, this petition is allowed.
